#### For those of you who missed it, here is a rundown of the 2013 Conference in Saratoga Springs: 2013 ANNUAL SPRING CONFERENCE, APRIL 26 AND 27 AT THE SARATOGA HILTON, IN SARATOGA SPRINGS

This year's spring conference was another resounding success. The theme was "Building the Farm Team, Growing the Party". Over 300 participants, from one end of New York State to the other, attended.

Friday the 26<sup>th</sup> included a number of presentations including: 1) "Defining and Cultivating Diversity in Your County Committee" led by DRC Chair Irene Stein; 2) a County Chairs' Roundtable led by Seneca County Chair, Ted Young: 3) NYS Board of Elections Campaign Finance facilitated by Jane Dodds, DRC Vice Chair.

Saturday's workshops included: 1) "Grassroots Campaign Management in a Nutshell" presented by former DRC Chair Denise King: 2) "Turning the Grassroots Blue" panel led by June O'Neil, former NYS Democratic Chair; and "What a County Can do to Spur Economic Development" by Martha Robertson, Chair of the Tompkins County Legislature.

In addition, Governor Cuomo hosted a wonderful Welcome Reception featuring New York State products. Attorney General Eric Schneiderman provided a delicious dessert reception and Comptroller Tom DiNapoli sponsored a sumptuous breakfast.

The NYS Young Dems had a late night fun event which introduced Ithaca's new dynamic young Mayor, Svante Myrick, to the DRC and activist Democrats. Joining us as well at the conference were Lt. Gov. Bob Duffy, Senate Minority Leader Andrea Stewart-Cousins, members of Congress and a number of state Assembly and Senate members.

Our annual event would not have been possible without the significant support of our incomparable U.S. Senators, Chuck Schumer and Kirsten Gillibrand, the New York State

Officers were elected during the conference. ### **BOARD MEETING AND RETREAT, JULY 13, WATERLOO, N.Y.**

Treasurer Cindy Emmer reported that we had a balance as of 7/13 of \$31,836. The DRC Journal generated a profit of \$12,600. A motion was passed to determine the amount of money to be awarded this year to each county during a conference call prior to Labor Day. Because each year's election needs are different, a second motion was passed to establish a subcommittee to explore how the money might be used in future years. In addition, the board discussed fund-raising ideas which included having a fund-raising event at the Fall State Committee meeting. Ideas were floated as to how to get additional ads in the Spring Conferences Journal.

### **COMMITTEE REPORTS**

#### **ISSUES COMMITTEE**

Issues Chair Dawn Rivers and John Hurley represented the DRC at a meeting with staff of the Lt. Governor's Office. The meeting focused on these issues:

The Regional Development Councils: Gaps in representation of significant stakeholders were discussed. In response, the DRC was asked to submit a list of overlooked constituencies and the names of individuals who might fill those slots. Dawn is seeking a list of such people and their affiliations. She will report to the Board before forwarding the information to the Governor's Office.

Mandate Relief: The DRC representatives indicated that mandate relief continues to be a major problem in rural counties. Ms. Rivers is seeking a list of these mandates that especially impact rural counties.

Education Funding: A request was made to change the funding formula in a way that helps low-wealth, low income areas.

Finally, concern was expressed about the new tax free zones, and particularly the aspect of no taxes for individuals employed in these zones.

After discussion, the Board endorsed the idea of an educational forum to discuss funding and related issues, perhaps to be held in early spring.

Early voting and the I-98 project were suggested as other issues which the Issues Committee might explore. ------Dawn Rivers

#### **2014 Spring Conference**

We have been holding our conferences in unionized hotels in DRC Counties. Since we need a hotel that can accommodate 300 people, we have few options. We agreed to search for a suitable venue in Syracuse, which is located in a non-DRC county. Jane Dodds, Conference Coordinator, was asked to put a "soft hold" on the Desmond in Albany, while we search hotels in Syracuse. A final determination will be made in a conference call in the coming weeks. The dates of the Conference will be April 25 and 26.

We reviewed evaluations from the last Conference so as to take suggestions into consideration for the next one. Many members wanted fewer speakers while many others commended the fact that so many speakers attended!

We discussed the 2014 agenda, the possibility of a straw poll, the desire to possibly have a Congressional panel and networking for both Congressional and State Senatorial candidates, in keeping with the 2014 political agenda.

#### **OLD BUSINESS**

Mark Bellardini and Jason Clark asked the Board to consider joining the I-98 advocacy group, the Northern Corridor Transportation Group. The Board and membership have already endorsed the I-98 proposal. The Board voted to join the Group as a Gold Member (\$1000).

Chair Stein reported that the Eleanor Roosevelt Legacy luncheon was scheduled for October 21 in NYC, and that the DRC will again have a table. She asked that Board Members indicate their interest in attending as soon as possible. If there will be extra space at the DRC table, we will open it up to the membership, as in the past.

#### THE RETREAT

Dr. Barry Warren, of SUNY Oneonta facilitated this three hour retreat. Because of the many changes in the DRC environment over the past years and because we had a number of new members, it seemed a good thing to review our goals, problems and successes in order to plan our actions for the coming year.

We hope to develop a public relations campaign to increase awareness of our existence, our achievements and our proposals. We also will follow up by strongly advocating for the I-98
