

Message from the DRC Chair

Dear Friends of the DRC:

2020 has been a year when customary practices and traditions have had to give way to the realities of a pandemic that has upended just about everything. When it became obvious that it would be unsafe to meet in April, the DRC Board and Officers postponed our annual conference until September. Since then New York has done extraordinary work in controlling the spread of COVID-19, but that is not true of the rest of the country. No one knows what the next few months will bring, and, as things currently stand, a gathering as large as the DRC would not be permitted. There's no way we can be confident it will be possible to meet in person this fall. Given the large financial commitment to the venue our conference requires, the Officers and Board have decided that this year's DRC will be a virtual, online one.

The main business we have to conduct virtually is to hold our 2020 elections. Besides half of the Board members, each region will be electing someone to the new positions of regional Vice Chairs. Please expect to be hearing from Chair Phil Jones and the rest of the Nominating Committee about how this year's elections will be conducted. The intention is that votes will be cast by regular mail both for security and to accommodate the DRC's weighted voting system. However, candidates will make their presentations prior to the voting by email and Zoom sessions (Zoom sessions can be done like a conference call, in case your computer or internet won't support video).

For those of you who have already registered for the 2020 DRC, please know that we will be happy to count your payment as your registration for the 2021 DRC. WHAT HAVE WE BEEN UP TO?

In March, as the pandemic first began to affect daily activities in New York, the DRC lobbied state officials successfully to shorten the petition period and reduce the number of required signatures by 70%. Later, we lobbied for changes in voting procedures, which helped drive the Governor's decision to permit all voters to use the absentee excuse 'temporary illness' in the June 23rd primary. More recently, we have been lobbying for authority to conduct judicial conventions and county reorganizational meetings via video or telephone conference, an effort that became successful Friday July 3rd when the Governor issued an Executive Order making party activity permissible virtually, notwithstanding any rules the particular body might have.

The Board held a conference call meeting on April 25 and Zoom meetings on May 16 and June 27. The April meeting included a presentation by Senator Schumer on legislation in Washington to address the pandemic. In May, Lt Governor Kathy Hochul spoke to us about efforts at the state level. The June meeting included a presentation by NYS Comptroller Tom DiNapoli. The business part of these meetings was mainly focused on lobbying efforts and planning in response to the pandemic.

In May, we sent a letter to NYS Senator Rachel May and Assembly Member Robert C. Carroll in support of their bill to permit online petitioning, S. 8238/A.10345. Online petitioning would not replace traditional door-to-door petitioning but would be an additional way to collect signatures for candidates. Our letter expressed caveats about the ongoing need for rural broadband support, the hope that the bill would not create another unfunded mandate for our counties, that it would be amended to include party positions (state committee members and judicial delegates), and that any online system would maintain local control of the process.

In June, we adopted the two resolutions which follow on the next page.

DRC Statement Regarding Systemic Racism, Police Reform, and Black Lives Matter

Drawing on the tradition and history of rural New York's role as a source of many movements for reform and equality in America, the Democratic Rural Conference of New York State affirms that Black Lives Matter. For so many of these small communities to turn out in such numbers shows how important this moment is. We commend the many Democratic candidates who have added their voices to this movement. And we will redouble our efforts to welcome, recruit, and encourage people of color to participate in every level of the political system.

WHEREAS Steven Jones was selfless in contributing to his community in Madison County through service to his clients, including municipalities and school districts, to local service clubs, to American Legion Boys State, and to many others, and

WHEREAS Steve's kindness, sunny disposition and relentless positivity were key to the DRC's success, and

WHEREAS He served as Madison County chair and on the state Democratic Committee for many years, and gave of his time and expertise to many campaigns, from local to presidential, and

WHEREAS as members of the DRC, all of us benefited from Steve's work as he set the standard for what we, as underdog upstate Democrats, should aspire to: persistence, integrity, humility, humor, and love,

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Democratic Rural Conference of New York State hereby recognizes, commemorates and honors the contributions of Steven Jones to the nation, the state, and his community through his hard work, devotion and time, and his role in the founding and success of the DRC;

Treasurer's Report – Frank Puglisi

Net bank account balance as of February 7, 2020 – \$11,262.70 Federal account balance as of February 7, 2020 -- \$5,956.00

- 1) We continue to lobby for universal rural broadband, which has become even more important under present conditions.
- 2) We will be lobbying for a November General Election COVID-19 absentee excuse like the one in place for the primary; the mailing of absentee applications to all registered voters; and additional time, resources and support for local Boards of Election to complete these tasks. Longer term, we will strongly support the proposed ballot resolution for fall 2021 to amend the state constitution and make direct mail balloting possible in New York.
- 3) The board continues to seek out attorneys who would be willing to serve on the Legal Service Bureau.
- 4) We continue to work on assembling a group that would travel to individual counties or do regional training on political how-to: building committees, recruiting candidates, running campaigns, fundraising, and get-out-the-vote work.
