Nominating Committee - Mr. Jones

Filling 9 positions at conference

- 4 Regional Vice-Chair
- 5 Directors

Elections will be held at the DRC conference regardless of whether held in person or virtual.

Election will be held using Election Buddy - virtual

All voting members of DRC, having paid dues will be able to vote whether in attendance at conference or remotely.

Proxy voting will not be allowed as all members will be allowed to vote.

Mr. Jones emphasized that there will be test votes – we need to take them seriously

Ms. Hunter – asked board members to help identify folks to consider running for a board position

The DRC continues efforts to look for geographic diversity on the board.

Straw Poll Task Force

At the December meeting we decided to cancel 02/05/2022 Straw Poll event.

We decided to move the poll to be part of the April conference

Task Force Report

Ms. Dobbs asked for clarification as to why associate members have to be county committee members from a DRC County.

Ms. Hunter explained that because the straw poll will happen after the state convention the board wanted as many rural county Democrats as possible to participate.

The questionnaire will be sent out 01/10/2022. All candidates must respond. Only those in contested races will be asked for interview.

Report from the Chair

Ms. Hunter reminded the board that NY State rules require alternating upstate / downstate

She noted that given where we are with covid the convention should not be held in person

Ms. Hunter wanted to know who is not attending in person so that she can report to Jay. Ms. Hunter will send an email to all county chairs so that she can report back "real" information.

Ms. Hunter reminded board member that members can only carry 5 proxies and they must be from state committee people in the judicial district.

By-laws Committee - Ms. Baker

<u>Issues Committee – Mr. Batman</u>

Talking with folks at the state on renewable energy siting rules. Making sure that rural counties are not used and get no benefit

Communications Committee – Mr. Thickstun

Mr. Thickstun is continuing to work on a newsletter in anticipation of the conference.

Ms. Hunter reported that the DRC Facebook page has 1,600 followers. She continues to post information and links we can use to inform our committee members.

Political Committee - Mr. Perfetti

Ian – described the REACH Project

Relational Organizing – use existing relationships merged with voter file to text for contact.

Extensive discussion about the positive aspects of the REACH program as well as the challenges

Problem with smaller races – contacts don't necessarily line up with district lines.

Easy to integrate with VAN

Challenge is to get buy in from committee people

First Lobby day in 2020 just beat covid shut downs

The Lobby Day was virtual in 2021.

Lobby Day 2022 will be January 28, 2022 - 3 sessions.

Issues to raise

- Election Reform
- Social Justice / Equity piece of the Marijuana legislation
- Redistricting

Ms. Hunter noted that it is hard to come up with a DRC position that is fair to each county. DRC is in a tricky spot because what is good for one county may work to the detriment of another. We should lobby for competitive districts.

Several board members mentioned that they were having issues with getting appointments through the Gov office. Many chairs share that they are having the same trouble

Ms. Hunter suggested that we should write to the Governor's office as a group (47 counties) to have the most impact.

Mr. Perfetti moved that DRC send letter to Governor's office expressing concern and frustration about the delay in getting appointments approved. Mr Young seconded.

Discussion followed

Mr. Schell recommended that we approach "inside" first before sending the letter to the Governor.

Ms. Hunter offered a friendly amendment that a letter be sent if we don't get a satisfactory response through less formal channels – Mr. Perfetti agreed / Mr. Hughes seconded. Vote to approve was unanimous

Conference Report - Ms. Dodds

The 2022 DCR Conference will be held April 29 – 30 at renovated Desmond in Albany

She reminded us that the dinner Friday is a good time to let elected officials and candidates become familiar with DRC.

Tentative programming starts early Friday afternoon. We will bring elected officials' staff and other government officials dealing with rural issues to respond to questions.

State Senate networking. Saturday – congressional networking / candidate forums.

We are working through the last of the details so that registration will open soon

Straw poll is currently scheduled for Saturday afternoon

Ms. Dobbs reminded board members that if they received a test ballot please open and vote so that we know that the system works and need the information provided.
